

## 2019 Dodgeville Summer Concert Series Official Rules

These are the Official Rules for Heartland Credit Union's ("HCU") 2019 Dodgeville Summer Concert Series (the "Promotion").

**NO PURCHASE, ACCOUNT OPENING OR LOAN IS NECESSARY TO ENTER OR WIN. MAKING A PURCHASE, OPENING AN ACCOUNT OR OBTAINING A LOAN WITH HCU WILL NOT INCREASE YOUR ODDS OF WINNING. PROMOTION IS VOID WHERE PROHIBITED BY LAW.**

**Terms and Conditions:** By entering the Promotion, you fully and unconditionally agree to abide by and accept these Official Rules. Failure to comply with these Official Rules may result in your disqualification from the Promotion.

**Eligibility:** The Promotion is open only to legal residents of the United States, who, at the time of entering the Promotion are eighteen years of age or older. All entrants must be natural persons; no entries from business entities accepted. Employees and Board Members of HCU, its affiliates, subsidiaries, advertising or promotional agencies, and their immediate family members (spouse or domestic partner, children and stepchildren) and/or those living in same household are not eligible to enter the Promotion. THIS PROMOTION IS VOID WHERE PROHIBITED BY LAW, RULE, REGULATION OR ORDINANCE.

**Promotion Period:** The Promotion begins on Wednesday, June 5, 2019 at 7:00 p.m. Central Standard Time (CST) and ends on Wednesday, June 5, 2019 at 8:30 p.m. CST (the "Promotion Period"). Only one entry per person is allowed.

**How to Enter:** No purchase necessary to enter or win. There are two methods of entry. During the Promotion Period, you may enter by:

- (1) Automatic Entry** – You will automatically receive one Promotion entry when you post a photo to Instagram using the hashtag #HeartlandCU. Photo must be taken and posted on Wednesday, June 5, 2019 between 7:00 p.m. and 8:30 p.m. Photo must be taken at the 2019 Dodgeville Summer Concert Series at Harris Park in Dodgeville, WI.
- (2) Alternative Entry** – You will receive one Promotion entry when you complete an *Official Alternative Entry Form*, which can be requested from any HCU representative at the HCU Summer Concert Series booth. Alternative entries must be received before 8:30 p.m. on Wednesday, June 5, 2019.

**Prize:** The prize ("Prize") offered is \$25.00 to Steph's Sweet Treats in Dodgeville, WI. Winner will be awarded the Prize in the form of a gift certificate or gift card. No cash alternative is offered.

**Winner Selection and Notification:** From all entries received during the Promotion Period, one winner will be selected by random drawing held on or about Friday, June 7, 2019. The odds of winning depend upon the number of entries received. The winner will be notified no later than Monday, June 10, 2019, via Instagram Direct Message.

**Taxes:** The Prize may be considered taxable income, and winner will be solely responsible for all federal, state, and local taxes. Winner will receive an IRS 1099 form reflecting the amount they receive as a Prize.

**Publicity:** Acceptance of the Prize constitutes consent for HCU to use your name and likeness for editorial, advertising and publicity purposes without additional compensation, except where prohibited by law. By participating in this Promotion, each entrant further consents to HCU's use of the personal information provided so that HCU may administer the promotion and award the prize. **Other Requirements:** The winner may, at HCU's discretion, be required to sign and return a declaration of eligibility, additional release of liability, and, where lawful, an additional publicity consent agreement. If a selected winner cannot be contacted, is ineligible, fails to claim a Prize, or fails to return the completed and executed declaration and releases as required, the Prize will be forfeited and awarded to an alternate winner.
